# INTRODUCTION

Today's chief legal officers (CLOs) and general counsels (GCs) are more driven to evolve their corporate law departments from cost centers to value creators. Yet they remain hindered by age-old challenges, including mitigating risk, working more efficiently and cost-effectively, and deriving more business insights from their legal operations.

In its comprehensive "Chief Legal Officers 2021 Survey," the Association of Corporate Counsel (ACC) revealed that only a quarter of CLOs surveyed are "very confident" about their organization's ability to effectively respond to certain types of risks, for example. Accordingly, 42% plan to adopt new technology to improve department efficiency over the next year. The ACC report implies the need for a shift, however fundamental, in legal management activities. It indicates an opportunity for in-house counsel to truly transform, in both form and function.

This has given rise to the need for one legal platform - a unified approach to automating legal management activities and supporting all enterprise functions. Unified legal platforms provide the robust features and advanced, end-to-end functionality that legal and other departments require most these days - a centralized repository; Aldriven document review, abstraction, and translation; legal risk and compliance management; and advanced analytics capabilities. With them, corporate departments can streamline processes, such as contract lifecycle, intellectual property (IP) and claims management, and GDPR and RFP review, as well as gain a holistic view of their work-related activities. Meanwhile, CLOs and GCs can take on higher-level responsibilities, extend their influence across departments, and help shape their organizations altogether.

## IN-HOUSE LEGAL LANDSCAPE

Today, the in-house legal landscape varies significantly — with departments operating at different paces and evolving in rather distinct ways.

Some legal departments are still completing work, such as contracting, in a manual fashion. But manual processes are often inefficient and may introduce additional risk. And ultimately, they may consume a lot of administrative time that could otherwise be applied to higher-value work.


Others, meanwhile, have progressed to employ individual point solutions




## OVERVIEW OF ONE LEGAL PLATFORM
